

ANNUAL ADMINISTRATIVE REPORT OF DEPARTMENT OF EXCISE, MANIPUR FOR THE YEAR 2018-19

1. INTRODUCTION:

The Department of Excise, Government of Manipur was established in the year 1948 under the Council Resolution No.23 of the then Maharaja of Manipur. Excise Department worked under the Eastern Bengal & Assam Excise Act, 1910 as extended to Manipur till the present Manipur Liquor Prohibition Act, came into force in 1991. Certain provisions of Eastern Bengal & Assam Excise Act, 1910 as adopted in the Manipur Liquor Prohibition Act, 1991 are still enforced. For narcotics and psychotropic substances, Department functions under the Narcotic Drugs & Psychotropic Substances Act, 1985.

2. AIMS AND OBJECTIVES:

The aims and objectives of the Department is to enforce Prohibition and collect revenue in the form of compounding/fine as well as levy and collect Excise Duty as provided in the acts. The main source of revenue collection is the Excise Duty levied on the liquor procured and used by military and paramilitary forces deployed in the state and the state armed forces which are exempted from prohibition.

3. ORGANISATIONAL STRUCTURE:

There are 706 sanctioned posts in the department including the post of Commissioner of Excise which is an IAS cadre post. Under the Commissioner of Excise, there is one post of Additional Commissioner of Excise and Superintendent of Excise and five posts of Deputy Superintendent to assist the Commissioner of Excise in the enforcement of prohibition and administrative works.

5. IMPLEMENTATION OF PROHIBITION IN 2018-19:

The Department is putting its best efforts to enforce prohibition in the state of Manipur. During the last Financial year 2018-19, the department has detected 3197 (Three thousand one hundred ninety seven) cases and collected a sum of Rs. 44,97,150/- (Forty four lakhs ninety seven thousand and one hundred fifty) only in the form of compound fee/fine. A huge amount of IMFL, Beer and country liquor with a value of more than Rs. 1.10 Crores has been confiscated and destroyed.

9. REVENUE TARGET AND ACHIEVEMENT OF THE DEPARTMENT:

The State Government has fixed Annual Revenue target every year for Department of Excise. The revenue collection of the Department is mainly in the form of Excise Duty levied from liquor procured by the Military and Para- military forces deployed in the State and State armed forces which are exempted under Manipur Liquor Prohibition Act, 1991. Revenue collection is also done in the form of compound fee/fine levied from excise prohibition offender as penalty and from license and renewal of license fee.

10. RECENT INITIATIVES IN THE DEPARTMENT OF EXCISE IN 2018-19:

1. The Manipur Liquor Prohibition (Second Amendment) Bill, 2018 (Bill No.9 of 2018) was introduced on 23rd July, 2018 in the State Assembly. The House has decided to form Select Committee consisting of 5 (five) Members to examine and report on "The Manipur Liquor Prohibition (Second Amendment) Bill, (Bill No.9 of 2018)". The Select Committee was formed vide Notification No.3/10(7) 2017-LA (Legn.) dated 20th August, 2018. The Select Committee meeting was held on **14th January, 2019** and **15th February, 2019** in the Committee Room of the Manipur Legislative Assembly Secretariat. The Committee discusses various aspect of The Manipur Liquour

Prohibition (Second Amendment) Bill, 2018 and decided to invite feedback from the general public. The amendment intends to allow manufacturing only for sale/export outside state of Manipur. The state government will generate revenue in the form of Excise Duty and VAT. It is estimate that about **Rs.350-400 Crores** per annum will be generated through Excise Duty and VAT.

2. The Election Commission of India has appointed the Commissioner of Excise as State Nodal Officer of Excise in 17th General Election to Lok Sabha-2019. The Commissioner has appointed 11(eleven) District Nodal Officer, 13 (eleven) Enforcement Teams of each District, 10 Check Post Team and support Staffs'. The Department has open 10 (ten) gates along enter State highways. A 24X7 Control Room was established at Excise Headquarter, Lamphelpat for receiving complain, gathering information and monitoring of the activities of the District Level Nodal Officer. In the process, a total of 13,373 liters with a value of **Rs.29,62,443/-** was confiscated and **Rs.7,81,700/-** was collected as compound fee/fine. A total of **943 raids** were conducted and **788 Excise cases** were registered. Manipur become the highest seizure of Liquor among North Eastern during General Election.
3. Uniforms/Liveries and furniture items were purchase for the staffs and Excise Station after a gap of 15 years. These acts boost the morale of the staffs and resulted in increasing the output of the staffs.
4. The Departmental Promotion Committee for promotion to the post of Accountant, Head Clerk, UDC, Sub Inspector and Assistant Sub Inspector was held on 4th October, 2018. The Committee recommended 143 Officials/Staffs for promotion to various posts. The Departmental Promotion Committee was conducted after a gap of 10 to 15 years.
5. The Department of Excise participated as Parade Contingent in the Independence Day Celebration 2018 and Republic Day Celebration 2019 after a gap of 12 years.
